1. ORGANIZING AUTHORITY

- 1.1. The 2018 Nyack One-Design Regatta is organized by Lightning Fleet #75, Sonar Fleet #23, and the Viper 640 fleet of the Nyack Boat Club.

2. RULES

- 2.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing, the Prescriptions of US SAILING, the respective Class Rules, this Notice of Race, the Sailing Instructions, and any amendments thereto.
- 2.2. For the Viper Fleet this regatta constitutes a WLIS Viper Fleet Circuit No 2 event.

3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to all boats of the Lightning, Sonar, and Viper classes. Eligibility for entry shall be in accordance with the Class Rules of each participating Class. Safety equipment may be inspected at random.
- 3.2. Registration will occur at the Nyack Boat Club on Friday, June 8, 2018 (Early Arrivals) or Saturday, June 9, 2018. See SCHEDULE for times. Registration, payment, and in person check-in must be completed before the Competitors Meeting.
- 3.3. Vipers: Online registration will be on Yachtscoring.com
- 3.4. Sonars: Use form attached.

4. FEES

- 4.1. Required fees are as follows:

<u>Class</u>	<u>Fee</u>
Lightning	US\$100.00
Sonar	US\$ 135.00
Viper	US\$ 100.00

- 4.2. Entry fees received after June 2nd will require a \$25.00 late fee.
- 4.3. The entry fee includes hospitality after racing on both Saturday and Sunday including Saturday dinner for 3 persons for Vipers and Lightnings and 4 persons for Sonars. Extra dinner tickets can be purchased separately during registration at \$25 per person.

5. **SCHEDULE**

5.1. Schedule of Events:

1015 All Sonars must be in water due to tide restrictions
1100 First Start. Starting Order of each Fleet will be provided in Sailing Instructions
1900 Dinner

Sunday, June 10th

1000 First Start. Order of each Fleet will be provided in Sailing Instructions

No start after 1500 hrs

Awards at NBC immediately after sailing

- 5.2. The Race Committee may adjust the racing schedule to suit weather conditions.

6. **SAILING INSTRUCTIONS**

- 6.1. Sailing instructions will be available during check-in beginning on Friday June 8th.
- 6.2. Vipers: Sailing instructions will be posted on yachtscoring.com.

7. **VENUE**

- 7.1. Races will be sailed in the Tappan Zee of the Hudson River

8. **SCORING**

- 8.1. Scoring will be in accordance with RRS Appendix A2.
- 8.2. One race completed constitutes a regatta for each fleet.
- 8.3. If 6 or more races are sailed, a boat's worst score shall be excluded. This changes Appendix A2

9. HAUL-OUT RESTRICTIONS - applies to SONARS only

Tides for Sonar Launching and Hauling. Moorings will be available and will be marked.

Friday, June 8th, launch after 1445 and before 2230.

Saturday, June 9th, launch after up until 1015, haul after 1530 if participating only one day.

Sunday, June 10, haul after 1600. Out of towners have first rights a lifts.

10. RADIO COMMUNICATION

10.1. Use of VHF radios is permitted. This may change respective Class Rules

10.2. The RC VHF Channel will be provided in the Sailing Instructions

11. PRIZES

11.1. Trophies will be awarded to the top three skippers and crews in each Fleet

12. DISCLAIMER OF LIABILITY

12.1. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. Sailing is an activity that has an inherent risk of damage and injury. The Organizing Authority, any Sponsors, Support Facilities, Volunteers, Agents, Employees and Service providers, the PRO, and the Committee will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after the Regatta for both on the water and on land activities. By participating in this event, each competitor (owners, skippers, and crew) agrees to release the race organizers and all persons and groups listed above from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

12.2. Vipers: The skipper and crew must digitally sign the liability waiver posted on Yachtscoring.com

13. INSURANCE

13.1. Each participating boat shall be insured with valid third-party liability insurance.
